

DISCLAIMER: *Grand Haven Boat Rental LLC* represents to the best of its ability and belief that said. *Grand Haven Boat Rental LLC* further represents that all required lifesaving vessel is free from any known faults or deficiencies which would affect safe and reliable operation under normal and prudent usage and safety equipment are provided and in excellent order and condition at the time of delivery to the RENTER.

Please read and initial each item as understood:

FUEL: RENTER acknowledges and agrees that fuel is **NOT INCLUDED** in the cost of the rental. RENTER acknowledges and agrees that he/she will return the boat with a FULL tank of gas at the end of the rental period. RENTER acknowledges and agrees that if the boat is not returned with a full tank of gas, **the fuel cost to return level to full, PLUS A SERVICE FEE OF \$25, will be charged to the RENTER.**

RETURN TIME: Boats must be returned no later than _____. If you arrive late for the start of your rental, the stop time does not change! **Late returns may be charged \$25 for every 15 minutes past the end of your rental period!**

TUBING/SKIING: There is a **\$50 charge** to pull a tube or skis behind the boat. You **MUST** use the equipment of *Grand Haven Boat Rental LLC* unless otherwise noted: _____. **The \$50 charge applies EVEN IF YOUR OWN EQUIPMENT IS APPROVED TO USE.**

RESTRICTIONS: * LAKE MICHIGAN IS PROHIBITED

RULES: * NO OPERATION OF VESSEL AFTER DARK * NO SMOKING * NO GRILLING

U.S.C.G. REG.: * RENTER MUST OBEY NO WAKE ZONES AND NAVIGATION RULES
* DO NOT OPERATE VESSEL UNDER INFLUENCE OF DRUGS OR ALCOHOL
* Children under 6 must wear a Personal Floatation Device (PFD) at all times!

BOAT OPERATION: RENTER acknowledges and agrees that the vessel will be operated by RENTER solely. RENTER warrants that he/she is a qualified operator of said vessel and equipment; that RENTER will not allow any other person to operate the boat. RENTER will not operate the vessel and equipment while under the influence of alcohol or drugs. RENTER will be responsible for the operation of the vessel within all laws.

SWIMMING: SWIM AT YOUR OWN RISK! Prior to swimming, RENTER agrees to FIRST turn off the motor and secure vessel in place by anchoring.

DAMAGES TO EQUIPMENT: RENTER acknowledges and understands that vessel is to be left in clean, undamaged condition, in the same condition as commencement of the rental period. RENTER acknowledges, understands and authorizes *Grand Haven Boat Rental LLC* to charge the credit card on file for any loss of equipment, damages sustained, or special cleaning required.

PET POLICY: Responsible pet owners may bring their family pet(s) for **\$25** and a signed **Pet Addendum**. RENTER acknowledges and agrees there will be NO pets on the boat without a signed **Pet Addendum** on file.

TOWING-REPAIRS-SERVICE CALLS: RENTER agrees to immediately notify *Grand Haven Boat Rental LLC* of defective or non-working equipment. *Grand Haven Boat Rental LLC* will make every reasonable effort to repair or replace defective equipment as quickly and efficiently as possible. Repair due to normal wear and tear on the equipment will be made by *Grand Haven Boat Rental LLC* **Should RENTER request a Tow or Repair on equipment that is found to be in working order and/or due to the problem of RENTER oversight, neglect or misuse, RENTER agrees that the towing costs, repair costs PLUS A \$125/HOUR SERVICE CALL may be billed to the RENTER.**

FINES OR FEES: RENTER accepts responsibility for, and acknowledges ownership, of any fines or fees incurred by RENTER during the rental period, regardless of reason or circumstance.

THEFT / LOSS: In case of theft or loss of vessel or its contents, RENTER is responsible for the replacement value.

LOSS OF RENTER'S PROPERTY: It is expressly agreed that *Grand Haven Boat Rental LLC* shall not be liable for loss of or damage to any property of RENTER or any other person through the duration of rental, or left in or upon said vessel after return thereof to *Grand Haven Boat Rental LLC*
